Paid carers have a very difficult role and emotional bond with the 'cared for' with inadequate support and inadequate funding Money is in the wrong place – tied up in buildings Economically everything is up in the air.</p> <p>Parish Plans- there are a lot of plans concerned with health and social care, these people could be consulted about how they see support being provided in their communities. Lots of people are concerned re support for carers.
